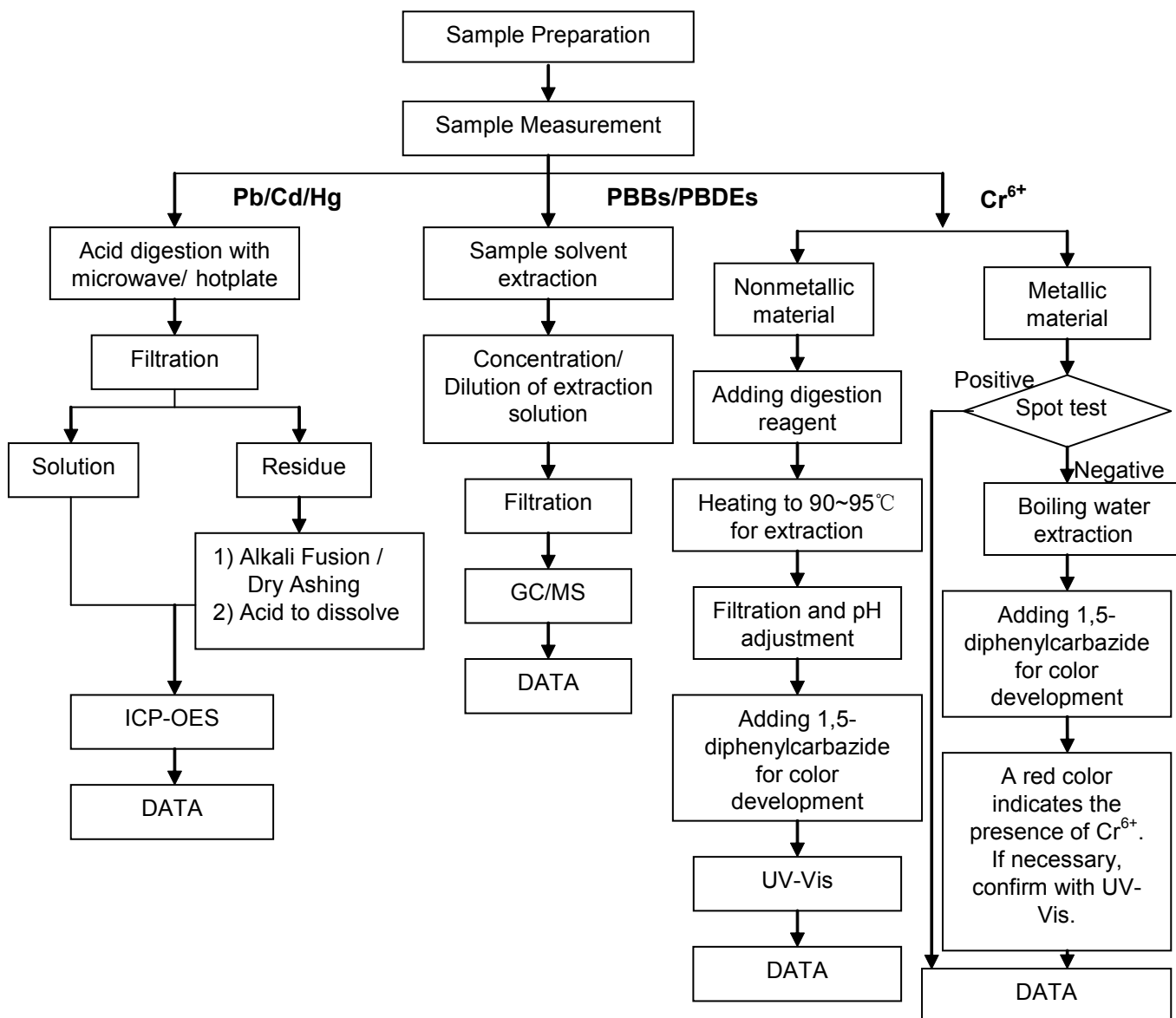

RoHS Testing Flow Chart

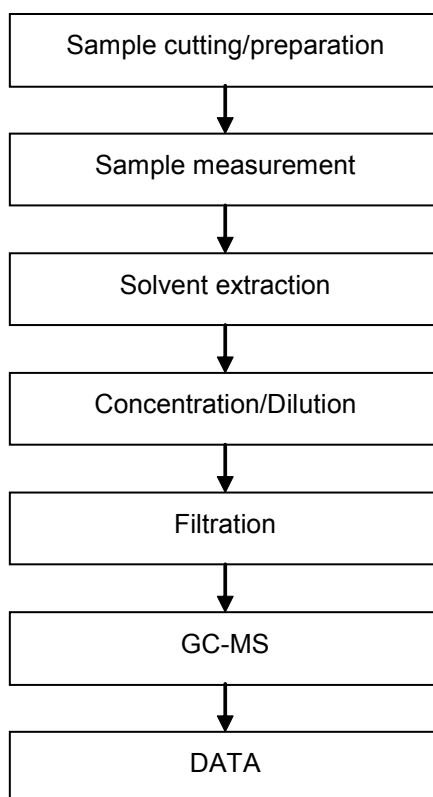

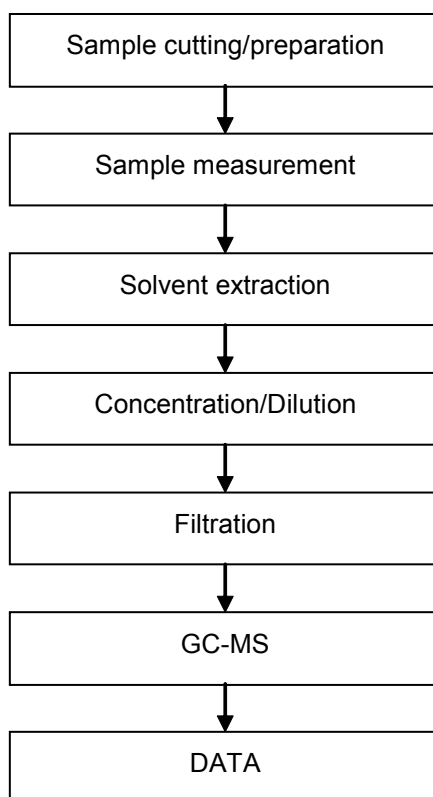

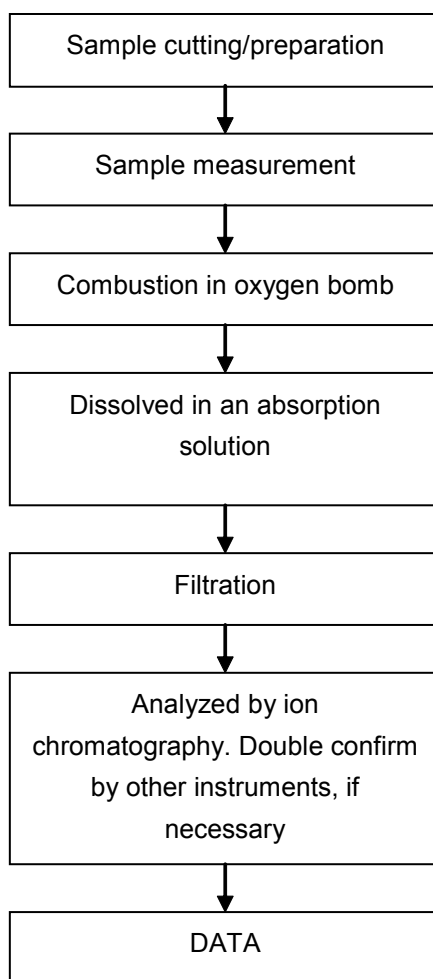
