

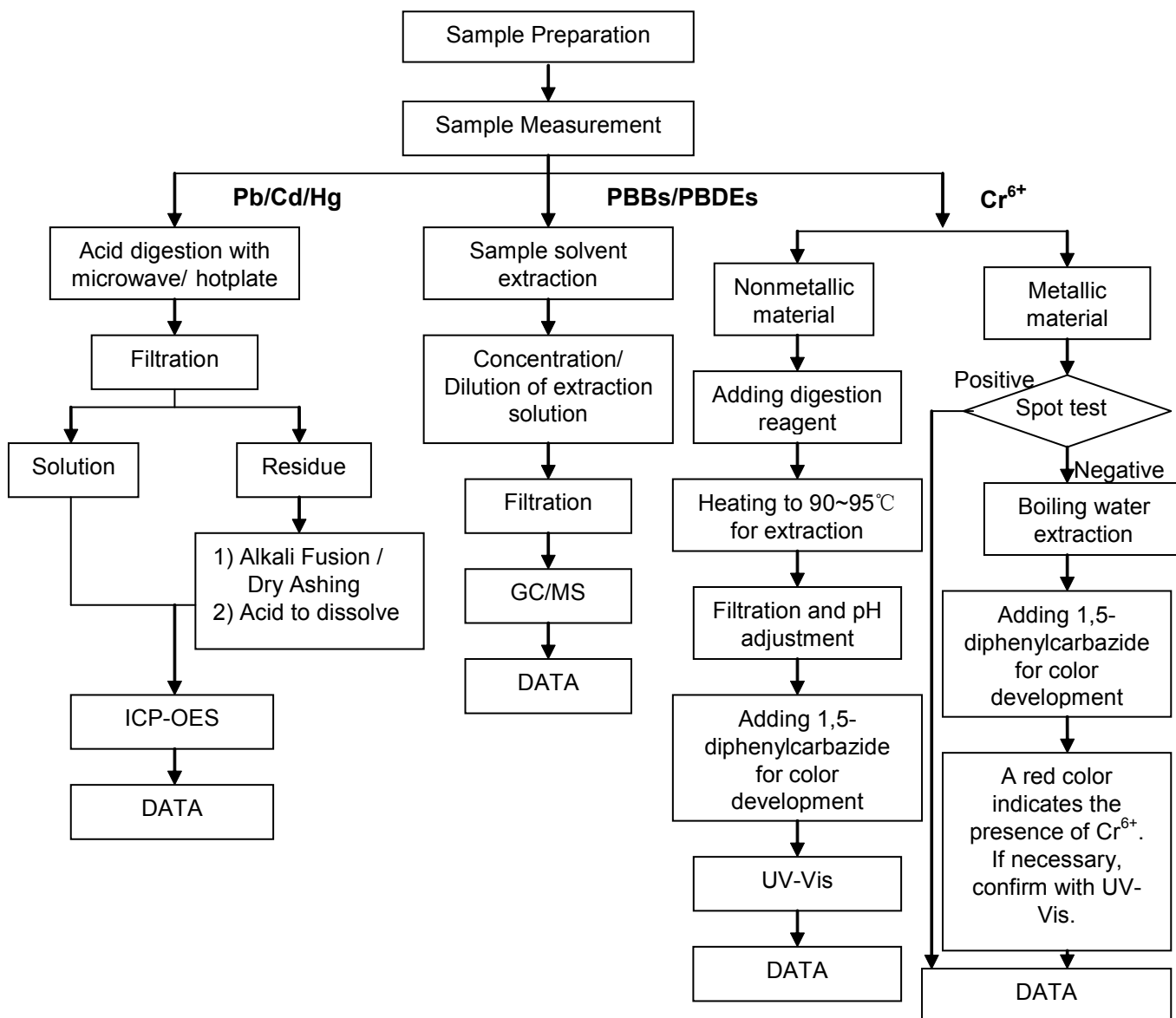

RoHS Testing Flow Chart

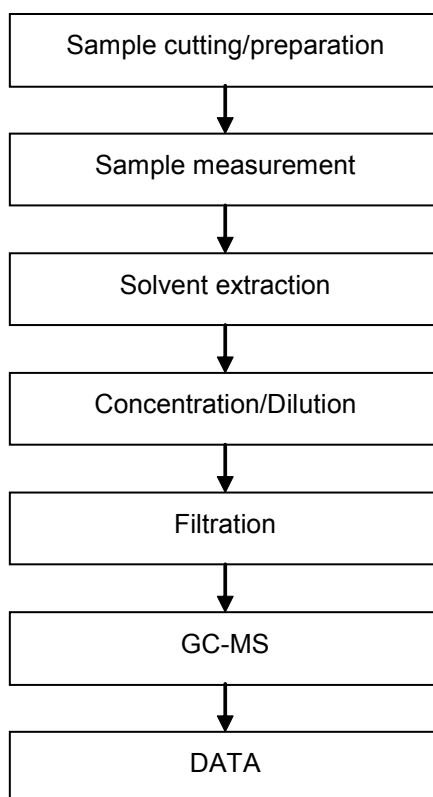

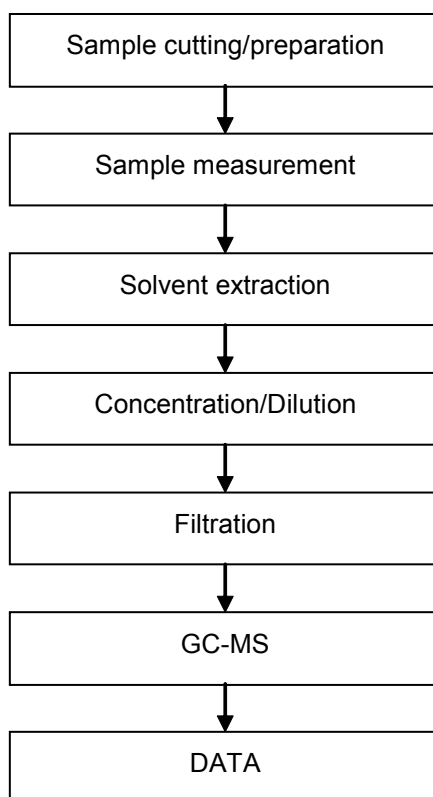

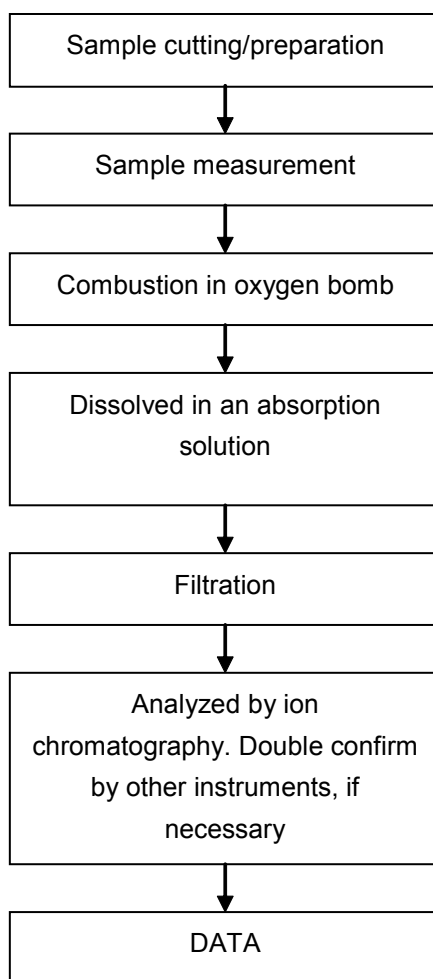
